- (1) Complete the entire application - inaccuracies will delay or disqualify the application;
- (2) Both the Applicant and Propane Marketer must sign the application;
- (3) Attach required documentation – a copy of the water heater receipt, and the safety inspection record (must have a service technician's signature) dated not more than 30 days prior to sending this application.
- (4) Keep a copy of the completed application and all necessary documentation for your records.
